Program Year 2020 Update

We are pleased to report that over 357 participants have successfully attested for Program Year (PY) 2020 early. Congratulations to the 131 participants who have completed six years in the Medicaid EHR Incentive Program! The program will remain open until April 13, 2021 and participants are encouraged to begin attesting or complete unfinished attestations.

New Program Year 2021 Closing Date

After careful consideration, The Department of Healthcare Policy and Financing (the Department) has decided to move the closing date for Program Year 2021 from August 8, 2021 to August 9, 2021 11:59PM. The decision now allows providers to have an extra full business day to complete attestations.

Public Health and Clinical Data Registry Reporting Documentation Delays

The Colorado Department of Public Health Environment (CDPHE) is responsible for Syndromic Surveillance, Electronic Lab Reporting and Cancer Registry active engagement letters for the Medicaid EHR Incentive Program. CDPHE has restructured to realign their staff to accommodate the COVID-19 response for Colorado. Due to this realignment, CDPHE active engagement letters for the Medicaid EHR Incentive Program have been delayed.

The Department is collaborating with CDPHE to find solutions to documentation letters for the Public Health and Clinical Data Registry Reporting (Objective 8). If you are waiting on letters from CDPHE, please submit your attestation without the letter and contact the Medicaid EHR Incentive Program Coordinator for additional guidance by emailing medicaidEHR@corhio.org.
