The MAPIR System Updates and EHR Incentive Program Tips page will allow providers to find information on what is new about the Medicaid EHR Incentive Program, known issues and updates for the MAPIR system along with daily updates for workarounds and resolved or known issues.

Success in Program Year 2016

The Medicaid EHR Incentive Coordinator works with the Department of Health Care Policy and Financing (the Department) and the Department's fiscal agent, MAPIR team (DXC), to help resolve any known issues and update information. The Department knows provider outreach is very important and contributes to participants attesting accurately and successfully. It is imperative that providers complete the attestation with correct information. If you feel your attestation was completed with incorrect populated or unpopulated information, email the [Medicaid EHR Incentive Program Coordinator](#) as soon as possible.

The CO R&A system has received 131 successfully submitted attestations and is expecting several hundred more in the coming weeks. If participants are struggling to complete attestations, make sure to contact the Medicaid EHR Incentive Program Coordinator for assistance and check the new webpage at www.corhio.org/MAPIR.

MAPIR Program Highlights

As previously noted, the Department has recently selected a new CO R&A system, starting with Program Year 2016 and CORHIO would like to highlight ways in which the new CO R&A system makes it easier for participants to attest to the Medicaid EHR Incentive Program. The new system is currently processing many successful attestations submitted by delegates, administrators and providers.

In this issue of the Medicaid EHR Incentive program newsletter, we are highlighting two outstanding achievements that have allowed for easier attesting through the MAPIR system.

Creating Delegates

Delegates can be created at the Provider Web Portal level rather than on the Centers for Medicare and Medicaid Services website or the Identity and Access Management system. Eligible Professionals, Eligible Hospitals and Critical Access Hospitals can create delegates to attest on their behalf very easily on the same portal providers are logging into before attesting. Once providers have assigned delegates with the functions to attest, they will carry over for future program years.

Electronic Signature

Another new feature of the MAPIR system is the ability to electronically sign an attestation by the provider or preparer—making attesting faster.

After uploading documents under the “Submit” tab, the MAPIR system will prompt for an electronic signature by the provider or preparer. Once the signature has been entered, there will be another prompt to submit the attestation.

The MAPIR system is valued for allowing for an easier attestation process and we want to continue to highlight the many benefits of this system.
